

This is a message from the California Department of Education (CDE), Early Learning and Care Division (ELCD).

Dear Child Care and Development Programs and Partners:

As the Desired Results Developmental Profile (DRDP) Online Support Team continues to improve the DRDP Online system, we appreciate the patience, persistence, and commitment to quality demonstrated by users of DRDP Online. With the input and assistance of users, system bugs have been identified and, in most cases, addressed. Users have suggested several enhancements for future system improvements.

Currently, many records have been processed and reports are available in DRDPtech, which is being maintained until we can fully transition to DRDP Online. We understand that not all records have been processed and are not yet available. We recommend agencies check in DRDPtech often for their reports. Reports will continue to be processed in the upcoming months with all data currently in DRDPtech processed by late spring. By the time reports are needed for the CDE, ELCD June 1st reporting date, reports will be available in DRDP Online. There are some ratings where the initial entry has changed due to system errors related to how ratings were saved and shared with our partners at University of California Berkeley Evaluation and Assessment Research (BEAR) Center. To the maximum extent possible, we have made the corrections without inconveniencing users. However, in some cases, to ensure that data is accurate and complete, we recommend users review the information in the system and correct as needed.

Please note, the system errors encountered in the fall data collection process have been addressed for the winter and spring collection periods. We truly appreciate your commitment to quality and patience as we work to develop DRDP Online. We are also continuing to work with BEAR to provide reports and will keep you updated.

In addition, please note for children with disabilities who have Individual Family Service Plans (IFSPs) or Individualized Education Programs (IEPs), DRDP ratings must be submitted into the Desired Results Access projects system to comply with federal reporting requirements. Data submissions into DRDP Online do not meet the federal reporting requirement for children with IFSPs or IEPs.
