# Dr. Ashley C. Williams: California's ECE Workforce: A Paradigm Shift from Expense to Benefit



Ashley C. Williams, EdD. is the Vice President of Programs at Jumpstart for Young Children where she leads the organization's workforce strategy to expand the pipeline of qualified, diverse talent pursuing careers in early education. Dr. Williams lends decades of experience to her role as her work over the years is situated in the nexus of early learning, family engagement, higher education, and policy with a specific focus on early educators.

She has worked in several early care and education roles, including serving as a Jumpstart Corps Member and team leader where she started her ECE journey. She continued on to become a preschool teacher, Head Start center director, and early childhood teacher

educator at the undergraduate and master's levels at SF State. She is the former Associate Director of EDvance and served as the Senior Quality and Workforce Analyst for the San Francisco Office of Early Care and Education. Before returning to Jumpstart as a part of the organization's leadership team, Dr. Williams was the Director of California Policy and Educator Engagement Programs for the Center for the Study of Child Care Employment. Her professional work extends internationally as she co-led a study abroad service-learning program in ECE settings in South Africa and New Zealand. Dr. Williams is also a Policy Fellow at the National Black Child Development Institute.

Overall, Dr. Williams' daily work is rooted in contributing to early learning systems in ways that explicitly reveal, dissolve, and resolve systemic inequities that cause harm to children, families, and the educators that work with them- especially when they are Black, Indigenous, and People of Color.

Dr. Williams earned her doctorate in Educational Leadership at SF State where she also earned her B.A. in Child and Adolescent Development and an M.A.Ed. with an emphasis on Early Childhood Education.

Kim Johnson was appointed by Governor Gavin Newsom as the Director of the California Department of Social Services in July of 2019. Ms. Johnson had previously been appointed by Governor Jerry Brown to serve as the Deputy Director of the Family Engagement and Empowerment Division and was responsible for the planning, policy direction and oversight of services to over 4 million individuals, children, and families, living in poverty through safety net resources, employment opportunities, and additional engagement strategies.

Ms. Johnson has over 20 years of experience working in various family support and children's programs focused on social justice, equity, and poverty disruption in both community-based organizations and government. She holds a degree in Social Welfare from the University of California, Berkeley.



# Lupe Jaime-Mileham, Deputy Director, Child Care and Development Division, California Department of Social Services

Dr. Maria Guadalupe "Lupe" Jaime-Mileham, is the Deputy Director of the Child Care and Development Division (CCDD) at CA Department of Social Services. Previously, since 2014, Lupe was the Senior Director for Early Care and Education at Fresno County Superintendent of Schools; and for over 14

years, was the Deputy Director at the Central Valley Children's Services Network, where she administrated many of the programs transferred to CCDD. Lupe earned a Doctor of Education degree from California State University Fresno in Educational Leadership, a Master of Education degree from National University in Cross-Cultural Education, and a Child Development Director Permit.

# Michael D. Tubbs: "A Conversation with Mayor Michael D. Tubbs"



What were you doing at age 26? Michael D. Tubbs was making history.

In 2016, he was elected Mayor of Stockton at 26-years-old. He was the city's first African-American Mayor, and the youngest Mayor of any major city in American history. As Mayor, Tubbs was lauded for his leadership and innovation. He raised over \$20 million dollars to create the Stockton Scholars, a universal scholarship and mentorship program for Stockton students. Additionally, he piloted the first mayor-led guaranteed income pilot in the country. Currently, he is the Special Advisor to California Governor Gavin Newsom for Economic Mobility and Opportunity; the Founder of Mayors for a Guaranteed Income (MGI); and the

Founder of End Poverty in California (EPIC).

Under his leadership, Stockton was named an "All-America City" in 2017 and 2018 by the National Civic League. The city saw a 40% drop in homicides in 2018 and 2019, led the state of California in the decline of officer involved shootings in 2019, and was named the second most fiscally healthy city in California. Additionally, it was recognized as one of the most fiscally healthy cities in the nation and was featured in an HBO documentary film, "Stockton on My Mind."

Tubbs has been named a fellow at the Harvard Institute of Politics and The MIT Media Lab, a member of Fortune's Top 40 under 40, All Star Alumni, the "Most Valuable Mayor" by The Nation, the 2019 New Frontier Award Winner from the JFK Library, and the 2021 Civic Leadership Award winner from The King Center. Prior to his tenure as Mayor, Tubbs served as a Councilmember for the City of Stockton District 6, a high school educator, and a fellow for the Stanford Design School and the Emerson Collective.

On November 16, 2021, Tubbs released "The Deeper The Roots: A Memoir of Hope and Home" published by the Flatiron Books imprint, An Oprah Book. The book—which the LA Times describes as "intimate and insightful"—not only relates Tubbs' story of growing up in poverty, but lays his vision for leadership and policy.
