The Child Care Resource and Referral Manager oversees this vital work, ensuring quality phone, walk-in, and web-based child care referral services and related resources for families of all income levels and diverse backgrounds seeking care in San Francisco. This position is responsible for developing training, providing clear procedures, and managing staff to ensure parents are connected to appropriate child care and resources that will help them thrive. This position requires strong people- and project-management skills. The ideal candidate is passionate about working with families and child care providers and is constantly thinking critically about how to enhance program quality and delivery to both types of customers.

### **Key Responsibilities**

- Manages and improves a complex, integrated system of service that includes child care resource and referral information database and quality customer service onsite and at partner-agency locations.
- Responsible for the training, supervision, and direction of the Child Care Resource and Referral 7-person team, including hiring, monitoring, training, coaching, reflective practice, and evaluation of staff.
- Responsible for developing outcome measures, cross-training staff, and ultimately ensuring
  a positive, productive experience for families, child care providers, and other community
  members who walk through our doors or phone us for assistance.
- Ensures the maintenance of a comprehensive and accurate database of licensed child care providers in San Francisco in coordination with the state licensing agency.
- Ensures compliance with California Department of Education contract, CA R&R Network and NACCRRA standards, as well as memoranda of understanding with local funding agencies and partners.
- Shapes, contributes to and is accountable for reports, dashboards and analyses of key
  performance metrics; compiles and analyzes input from all staff and community stakeholders
  to develops strategies for program improvement.
