### General Purpose of the Job:

- Provide Family Navigation to families applying for services through the Emergency Child Care Bridge Program
  - Assist families in obtaining and accessing emergency child care, completing child care program applications and enrolling child into child care that meets their needs
  - Connect families to programs and services throughout Solano County including school readiness and ongoing child care subsidies
  - Develop a family support plan with the family for long-term child care including plans where possible to minimize child care transitions or disruptions for the child
- Provide trauma-informed education, training and coaching to child care programs
  - Training includes, but not limited to, infant and toddler development and research-based, trauma-informed best care practices for children in the child welfare system
  - Provide coaching to child care providers caring for children enrolled in the Emergency Child Care Bridge Program to assist them in applying training curriculum and learn strategies for working with children in foster care
- Track and collect data required for reporting to program funding source
- Assist management in developing, implementing and applying policies and procedures related to the Emergency Child Care Bridge Program
- Participate in community meetings, outreach and training events
- Other duties as required

### Minimum Requirements:

- At least one year training and development experience preferred
- Experience creating, organizing and preparing training materials preferred
- Two years experience in a position involving community, social services, or working with child care providers
- AA degree in Child Development, Liberal Arts, English or Training Certificate preferred; OR equivalent combination of education and experience
