### Successful candidates will need the following:

- Bachelor's Degree preferred in the field of Instructional Design, Training, Education, Learning Management, or related field with a minimum of 3-5 years of related work experience in curriculum development utilizing adult learning principles.
- Solid knowledge of and experience with learning management systems (LMS), course development software, and e-courses.
- Experience with adult learning theories, instructional design models, and job training methods and techniques that would make training materials effective.
- Proficient computer skills with the ability to use current software and learn new software that supports the facilitation of training and development of e-courses, presentations, exams, etc.
- Strong working knowledge and ability in developing a variety of training materials used to present information to both large and small audiences.
- Knowledge of testing and measurement theories to create reliable examinations.
- Enjoy working independently while collaborating with Program Trainers.
- Excellent verbal and written communication skills.
- Discretion in handling confidential information, with the ability to honor confidentiality, work sensitively and supportively with staff.
- Ability to maintain a cooperative, diplomatic relationship with co-workers, supervisors, and managers in all departments.
- Ability to interact effectively with County and State Appeals Coordinators, Consultants, and Auditors on technical aspect of DPSS Stage 1 Contract, CDE Title V, Funding Terms and Conditions, and Agency Policy.
